

Your Warranty.

- PLEASE READ THROUGH THIS ENTIRE WARRANTY PAGE.
- CoverMyAss Trailer Covers warrants this product against defects for a period of two years from the date of purchase.
- CoverMyAss Trailer Covers will repair or replace the product, at its discretion, should a warrantable defect arise within the warranty period.
- If the exact model is unavailable a model of equivalent nature will be substituted at our discretion.
- This warranty excludes faults & failures caused by improper use & abuse; fair wear & tear; or failure to follow instructions regarding installation, usage & removal, storage and care & maintenance of the cover. Improper use may include/but not limited to, attaching the cover to an incorrect size trailer, without all tie-downs & supports, on a non-caged or partly caged trailer, driving with open sections; this cover system must be fitted to correct sized trailer as a complete unit with all sections, doors, vents, zips & Velcro sealed.
- -- This cover is not intended as a permanent structure or dwelling. The PVC in this cover is UV Stabilized for short term use. When storing cover, store out of prolonged direct sunlight.
- DO NOT EXCEED 100kmph with trailer cover attached to your trailer. Resulting damage from excessive speed will void warranty.
- Due to the dual use nature of the COVERtoCAMPER Trailer Cover, damage or wear and tear to windows, fly-screens & vents are not covered in this warranty. Sharp or protruding loads which may shift or contact and damage the cover during transport will void warranty.
- Damage from storing the cover wet and resulting mould or mildew is not covered by this warranty. Make sure the cover is totally dry before storage. If the cover must be stored away wet due to unforeseen rain or mist, dry the cover as soon as possible.
- A warranty may be claimed by returning the product to its place of purchase, with a detailed proof-of-purchase clearly showing the date & detail of the purchase.
